RE: 2024-205 HOD Delegate Apportionment

Article VI, Section 2 of AAPA’s bylaws outlines the composition of the House of Delegates, and specifically the allocation of seats in the House for chapters, caucuses, specialty organizations and students. As noted in the bylaw, apportionment for each leadership year (July 1st to June 30th) is determined by the number of AAPA fellow members in a chapter as of January 31st prior to that leadership year.

Each chapter has a minimum of two (2) delegates regardless of its size. When the number of fellow members within a chapter’s jurisdiction exceeds 220, it will be apportioned a third delegate. An additional delegate will be apportioned for every additional 300 members.

Student delegates are apportioned at a straight ratio of 1:850. Specialty organizations (SOs) and Caucuses each have one delegate per organization. The immediate past and current House Officers are considered “delegates at large” and comprise the remainder of the HOD.

Please reference the attached information which reflects the number of delegates your organization is apportioned for the 2024-2025 leadership year, to include the 2025 House of Delegates meeting in Denver, CO from Friday, May 16 through Sunday, May 18, 2025. All delegate terms for the 2024-25 leadership year will begin on July 1, 2024 and continue until June 30, 2025; regardless of when your CO’s leadership term begins.

Please submit the names of your organization’s 2024-25 delegates **by July 1, 2024 or as soon as possible**. This allows AAPA to ensure the elected delegates for the current leadership year are kept informed of critical and pertinent information throughout the year and are prepared to conduct business should the need arise.
