Using AAPA's Learning Central

Go to cme.aapa.org, log in using your AAPA credentials. On the **2024 Leadership and Advocacy Summit (LAS)** landing page you can access daily CME sessions, CME FAQs, and the CME Quick Guide. Navigate to CME sessions by selecting the navigation tabs at the top.

CME Quick Guide

Submitting AAPA CME Credits to NCCPA via AAPA's PA Portfolio

Log in to paportfolio.aapa.org using your AAPA credentials. Select the CME tab from the top navigation menu. Locate **2024 Leadership and Advocacy Summit (LAS)**, click the + sign to expand the list of completed sessions. Click the Send button next to the AAPA CME credit(s) that you would like to submit to NCCPA. First-time users of the NCCPA credit transfer feature need to link your PA Portfolio account to your NCCPA account by clicking the Refresh button and entering your NCCPA login information when prompted. The page will refresh and indicate the credits available within your earning window to send to NCCPA. In your NCCPA account select the CME tab, select Confirm CME, verify information is correct, select credit(s), and confirm selection. The process is complete only if you log in to your NCCPA account and **CONFIRM**.

Want to report your credits to NCCPA from AAPA's PA Portfolio

1. Activities must be "Confirmed" at NCCPA.
2. Status reflects only actions taken in PA Portfolio.
3. Credits will be posted to the earning window if allowed.
4. Credits reflect AAPA award values. Any changes to the award value will be reflected in the earning window.
