Whereas, the shortage of qualified providers continues in the primary care fields of family medicine, general internal medicine, pediatrics, and geriatrics; and

Whereas, the benefits of practicing primary care require more subtlety and care to appreciate, as compared to the perceived prestige or superlative salaries of certain specialties;

We resolve to encourage students to deepen their understanding of both the need for and the satisfaction derived from primary care practice, by spending significant clinical rotation time in primary care fields, and to carefully consider a career in this crucial corner of care.
